- a. SUP 20-05: Redfish Solar Partners, LLC

The Board of Supervisors will consider a Special Use Permit application from Redfish Solar Partners, LLC to construct and operate a solar energy generation facility on vacant property located on Catharpin Road in the Locust Grove/Mine Run area. The property is identified as Tax Map Parcels 50-4 and 50-4A, contain 48.29 acres each, and are zoned Agricultural (A). The property is situated in the Agricultural (A-2) Recommended Future Land Use category, as described in the Orange County Comprehensive Plan.

b. Proposed Lease of County-Owned Property

The Board of Supervisors will consider a lease with Anthony A. Mayo of County-owned property located at 27531 Constitution Highway in Rhoadesville, Virginia.
