

BOARD OF SUPERVISORS MINUTES

JULY 22, 2025

At a Worksession of the Orange County Board of Supervisors held on Tuesday, July 22, 2025, beginning at 3:00 p.m., in the Meeting Room of the Public Safety Building, 11282 Government Center Drive, Orange, Virginia. RE: CLOSED MEETING

At 3:00 p.m., Ms. Wilson read the following motion authorizing Closed Meeting:
